The FAA requires each applicant to have both "ground" and "practical" flight training experience, leading to the student to pass the practical tests. Every pilot learns differently, so to achieve FAA desired proficiency, one may need extra training. For any extra hours, our rate list is mentioned below.

Piper Pilot 100i-	\$ 235.00 / hour
Instructor-	\$ 89.00 / hour
Tecnam P2006t-	\$ 345.00 / hour
Sim-	<b>\$ 299.00</b> / hour

Ground Instruction charges are divided between Group Ground school and flight pre & post briefing. This course requires you to be at the airport daily, Monday through Friday, 25 hours per week raining (minimum), working with an assigned 'Primary' and 'secondary' instructors.

Estimates for Practical Test fees and FAA written Test Fee are mentioned below – NOTE – that these charges are by the FAA to conduct the tests.

All International Students are required to have M1 VISA issued by a SEVIS approved Flight School. Students need to e-mail *info@firstlandings.com* the completed Application for I-20 with a scanned copy of your passport, and your account will be generated in our flight school system.

Once we receive all of the required documentation, First Landings will issue an I-20, and send a scanned copy to the student via e-mail, and courier the original to the students home address. Once students have received their I-20, they will need to pay the US "SEVIS" VISA fee, and then schedule a VISA interview appointment with the US Embassy or US Consulate.

Once the student has been approved for their US VISA, students will then need to apply for Flight Training Security Program (FTSP) or "TSA" fees, and then make travel arrangements.
